Terms & Conditions

1. Once you are in New Zealand you are under the jurisdiction of New Zealand law. As an Arya you are expected to abide by these laws at all times.
2. As a representative of your Samaj at this sammellan, you are expected to be participating in all the activities organised on all the three days.
3. It will be an expectation of the participants that the programme times are strictly adhered to, so that the timeliness and the effectiveness of the sammellan is not compromised in any way.
4. Vedic Centre site will be alcohol, kava, smoke and meat (including chicken, fish and egg) free at all times.
5. When participating in the sammellan programmes, all the participants are expected to maintain silence and the cell phones are to be either turned off or set to silent mode to minimise any disturbances.
6. When speaking on any issue every participant is expected to use parliamentary language at all times.
7. No one will be allowed to distribute or sell anything without prior written permission from the Sammellan Organising Committee.
8. For identification purposes, you will be required to wear the Sammellan tag at all times when you are at the sammellan. This tag will be issued to you at the time of registration. We will not be able to give you a replacement tag if you lose or forget to get it to the sammellan.
9. No participant will be allowed to address the Sammellan unless permission has been granted by the Chairman or the Secretary of the Organising Committee.
10. No individual, groups of individuals, Samaj or Sabha will be allowed to raise or discuss any personal issues, issues related to any person/Samaj/Sabha at any Sammellan activities.
11. Should any participant break any of the above rules then he/she will be warned on the first occasion by the Chairman or the Secretary.
12. The Chairman or the Secretary or organising committee members will take appropriate disciplinary action on any participant(s) who breach(s) the rules the second time.
13. The disciplinary action can include but not limited to:
 - Not allowing the participant(s) to speak on any further issues
 - Requesting him/her/them to leave the Sammellan venue.
14. The disciplinary decisions taken by the organising authority will be final and no further discussion or correspondence will be entertained.
15. This is a Sammellan of Aryas so we do not anticipate any of the above issues. However, keeping within the law of the land we have an obligation to state them at all public gatherings.
